This item comes with 12 month all parts warranty for domestic use, and 3-month warranty for commercial use. If the product arrived to you with major damaged or manufacturing fault, we will arrange to have the item picked up and replaced under the seller's cost.

This claim must be made within 7 days of receiving the item. Please be advised that photo or short video will be requested to support the claim.

The replacement item will only be dispatched after the return product is received. If you have any issue with your item after 7 days it is to be repaired under warranty, we do not replace or refund an item after 7 days, by purchasing from Bargains Online you understand your item is under warranty to be repaired.

For any issue within 30 days of receiving the item, Bargains Online will cover the shipping cost in returning the item. Otherwise, any issue after 30 days of receiving the item, the cost of transport both ways for inspection or warranty is at the buyer's cost. Bargains Online will cover the cost of returning the item back to you if manufacturing fault is detected upon inspection.

Any faulty part will need to be returned back to us. Upon receiving the part, we will then repair or replace the faulty part. Shipping and labour in fitting parts at buyer's home or location is at the buyer's responsibility.

- Loose or broken foundation wire through any fabric
- Compression of modules

# This warranty **DOES NOT** cover the following:

- Mattress fabric

- Border wires, which run along the perimeter of the mattress (innerspring) and foundation, bent due to moving or folding the sleep set

- Comfort layer and materials
